Background Information

A. Movie in the Park

Due to rain in June, the Movie in the Park was rescheduled to Friday, August 20, 2021. The movie will begin at 8:00 pm following sunset at the Community Park. The City invites all families to join us for Movie in the Park in this back-to-school event. The featured movie will be Disney Pixar's *Onward* which follows two teenage elf brothers who embark on an extraordinary quest filled with magic spells, cryptic maps, impossible obstacles, and unimaginable discoveries. The Movie in the Park is free to the public and parking will open at 7:00 pm. Free prepackaged snacks and drinks will be provided to attendees at the park pavilion. Families are welcome to bring lawn chairs, blankets, and pillows to the back-to-school movie event.

B. Public Lands Trail Cleanup

In partnership with the United States Army Corps of Engineers and Trinity Trail Preservation Association, the City will be holding the Public Lands Trail Cleanup on Saturday, September 25, 2021. The cleanup event will take place at the Brockdale Park Trailhead from 9:00 am to 1:00 pm. The Public Lands Trail Cleanup is in support of National Public Lands Day which promotes popular enjoyment and volunteer conservation of public lands. National Public Lands Day is celebrated annually at public lands in the United States on the fourth Saturday of September. Volunteers will check in at the Brockdale Park Trailhead and staff will safely transport volunteers to and from nearby trail cleanup areas. Online preregistration will be available on the City's website in early August.

C. North Texas Community Cleanup Challenge

The North Texas Community Cleanup Challenge is a friendly competition among North Texas communities to see who can pick up the most litter. At the end of the contest, the community with the most litter cleaned up per resident will receive the North Texas Community Cleanup award that they can proudly display at City Hall. Each year, the trophy will move from community to community, each adding their name to the legacy of litter cleanup efforts. The challenge timeframe runs between September 1 and October 31, 2021. The City will be participating in the challenge as the Public Lands Trail Cleanup will take place during the challenge timeframe.

Discuss potential parks improvement projects to be considered for the Local Parks Grant by Texas Parks & Wildlife.

Background Information

The Local Parks Grant Program by Texas Parks & Wildlife is now accepting applications to assist local units of government with the acquisition and/or development of public recreation areas and facilities throughout the State of Texas. The Program provides 50% matching funds on a reimbursement basis to eligible applicants. All fund-assisted sites must be dedicated as parkland in perpetuity, properly maintained, and open to the public. Funding for these programs comes from a portion of the state sales tax on sporting goods and additional funds come from federal offshore oil and gas royalties through the Land & Water Conservation Fund.

Assistant to the City Manager Kent Souriyasak participated in the Local Parks Grant Workshop. Below are highlights from the workshop:

- 50% matching funds. Grant is provided through reimbursement and will award up to \$150,000 in matching funds.
- Eligible costs include acquisition of land, new construction, renovation, and professional services.
- High priority is given to projects with recreational elements (dog parks, soccer fields, tennis courts, playgrounds, etc.) instead of support facilities (parking, bathrooms, etc.).
- Grant applications are due by October 1, 2021.

Background Information

At the request of Alternate Parks Board Member Pam Poteete, this item was placed on the agenda for discussion and consideration.

GaGa ball is a fast paced, high energy game played in an octagonal pit. The game is played with a soft foam ball and includes dodging, running, and jumping, while trying to hit opponents with a ball below the knees.

GaGa ball courts are between 16 to 20 feet in diameter. The floor can be the grass, dirt, artificial turf, or rubber mulch. Permanent pits are usually made of wood and can be custom built or purchased by a vendor. Wooden pits can cost between approximately \$3,000 to \$6,000.

Alternate Parks Board Member Pam Poteete is interested in promoting neighborhood beautification to encourage individual homeowners to actively clean up and beautify their neighborhoods. Some possible program ideas to discuss are:

- Yard of the Month Promote goodwill and reward exemplary lawn care in the community. The purpose of the program is to recognize neighbors who demonstrate above-average efforts in maintaining their property, thereby contributing to the overall appearance of the community at large.
- Monthly Newsletter Article Themes Encourage best practices for individuals to take care of their property such as protecting pipes and pool equipment, applying preemergent to lawns, and neighborhood cleanups.
- Neighborhood Entryways Encourage individual homeowners in yard beautification and community involvement in neighborhood entryway maintenance.

Consider planting wildflower areas in the City of Lucas and recommend locations to the City Council for consideration.

Background Information

At the March 23, 2021, Parks and Open Space Board meeting, Parks Board member Laura Giles brought forward the suggestion of identifying and planting a wildflower area within the City. Staff identified two locations where wildflowers could be planted: 1) 151 Country Club Road located at the intersection of Country Club Road and West Lucas Road, specifically the building pad area; and 2) the East Winningkoff Trailhead in the open area behind the coral near the East Winningkoff water tower. Both locations potentially reduce maintenance costs leaving less area for mowing and would be considered a beautification project for either area. Both areas have adequate parking, and the East Winningkoff Trailhead has the advantage of restroom facilities. Wildflower seeds are available at no cost.

Should the Parks Board want to move forward with this project, a recommendation to the City Council will be required.
